A STRIP OF LAND BEING 16 FEET WIDE AND SITUATED IN THE NORTHEAST QUARTER OF SECTION 30, TOWNSHIP 38 SOUTH, RANGE 9 EAST OF THE WILLAMETTE MERIDIAN, KLAMATH COUNTY, OREGON, SAID STRIP OF LAND BEING 8 FEET ON EACH SIDE OF THE FOLLOWING DESCRIBED CENTERLINE:

Commencing at the northeast corner of property described as identification number 2095 as shown on County Survey 5053 on file in the Klamath County Surveyors Office; thence southerly, along the east property line of said number 2095, 23.78 feet to the centerline of an existing 8 inch sanitary sewer line and the true point of beginning; thence S 66° 24' 08" W, along said centerline, 196.63 feet to a point on a line that is parallel with and 15 feet southwesterly of the southwest property line of said number 2095, said point being the end of said 16.00 foot wide easement.

The side lines of said strip to be shortened or lengthened to terminate on the beginning and ending lines as described.

Grantors shall not erect any structures, nor plant any trees or shrubs, within the easement area which would inhibit access to said City sewer line or cause damage to it.

The City, its successors or assigns, for damage to the above-described premises occurring in the use of this easement, shall repair same and place said premises in as good condition as they were immediately prior to such damage.

This document shall be binding upon all subsequent purchases or the above-described parcel(s), the City, and the heirs, successors and as _gns, of both.
