KNOW ALL MEN BY THESE PRESENTS, That Walton H. Reeve and Betty J. Kurtz

hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by Lonnie Carlton Thatcher & Theresa Susan Thatcher, husband and wife, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the grantees, as tenants by the entirety, the heirs of the survivor and their assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Lots Four (4) and Five (5), Block One (1), New Pine Acres, Tract #1015, Klamath County, Oregon.

To Have and to Hold the above described and granted premises unto the said grantees, as tenants by the entirety, their heirs and assigns forever.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
