MEMORANDUM OF RESTRUCTURE

Benson C. Edwards and Marie F. Edwards ("Borrower"), whose address is 14240 W. 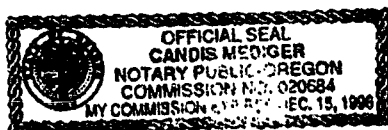

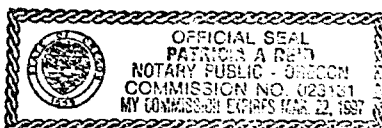

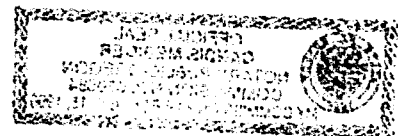
