A careful search of records kept at the Klamath Basin Area Office failed to provide any data that would support the additional Right-of-Way on the No. 6 Drain South of Falvey Road. The only documentation of record to our knowledge is the Warranty Deed given by the Bryant's to the United States (Copy Attached). This Deed shows the Right-of-Way as being 60 feet wide from Falvey road to the Lost River.
