

- Parcel 4: The W½ of the SE¼ of the SW¼ of the SE¼ of Section 34, Township 32 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon.
- Parcel 5: The NW¼ of the NW¼ of the NW¼ of Section 17, Township 33 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon.

In construing this instrument and whenever the context so requires the singular includes the plural.



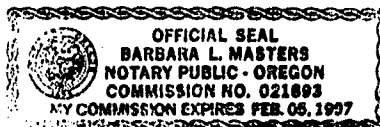
