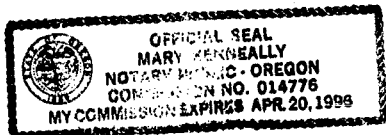
## AND REQUEST FOR RECONVEYANCE

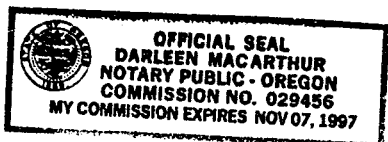
