DECLARATION OF HEIRSHIP

5. At the time of the death of Alice Pearson there were no children who predeceased her.

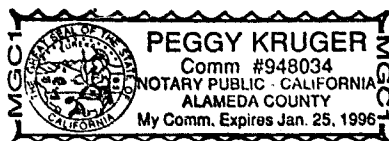

I, ALICE PEARSON, a resident of Santa Clara County, California, declare that this is my Will.

FIRST: I revoke all Wills and Codicils that I have previously made.

SECOND: 1. I was previously married to Thomas Harvey Pence, which marriage was terminated by divorce in 1930. I had one child from that marriage, A. LORRAINE MILLER.

2. I married HARRY CARROLL PEARSON on September 5, 1953, which marriage terminated upon his death on November 8, 1979. No children resulted from my marriage to him and I have not since married.

3. I have one (1) child now living, A. LORRAINE MILLER. I have no deceased children leaving issue surviving. I have three adult grandchildren now living, the children of A. LORRAINE MILLER, whose names are: NORMAN S. MILLER, MARILYN J. BEATTIE, and PEGGY A. ANDERS. DOUGLAS B. MILLER, my grandchild, a Deputy Sheriff of Santa Clara County, died in the line of duty in 1986 without leaving issue surviving him.

THIRD: I give all my estate to my daughter, A. LORRAINE MILLER, if she survives me for one hundred twenty (120) days, and if she does not, I give all my estate to my issue who survive me for that period, by right of representation.

FOURTH: I nominate my son-in-law, WALTER H. MILLER, the husband of my daughter, A. LORRAINE MILLER, as Executor of this Will, to serve without bond. If he shall for any reason fail to qualify or cease to act as Executor, I nominate my grandson, NORMAN S. MILLER, as Executor, to serve without bond.

FIFTH: My estate may be administered under The California Independent Administration of Estates Act.

SIXTH: I authorize my Executor to sell, with or without notice, at either public or private sale, and to lease any

property belonging to my estate, subject only to such confirmation of court as may be required by law.

SEVENTH: As used in this Will, the masculine, feminine, or neuter gender, and the singular or plural number, shall each be deemed to include the others whenever the context so indicates.

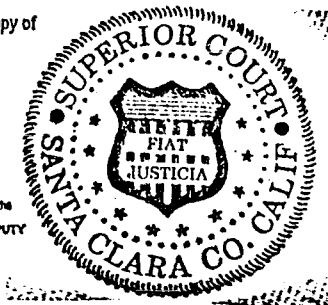
