No annual payment has been due on the Contract; and

WHEREAS, Antonio F. Troquato, Sr. did not make the timely payment as required by Section 7 of the Land Sale Agreement, and is now in default under the term of the Land Sale Agreement; and

WHEREAS, on November 29, 1994, certified letters were mailed to Antonio F. Troquato, Sr., requesting that the annual payment be paid current on the property and the return letters were received from December 2, 1994 until February 21, 1995; and

WHEREAS, no payment has been made and the Land Sale Agreement is now in <u>DEFAULT.</u>

NOW, THEREFORE, IT IS HEREBY ORDERED, that the Land Sale Agreement between Klamath County and Antonio F. Troquato, Sr. dated November 4, 1993, is hereby declared null and void.
