RESOLUTION # 96-002

WHEREAS, on the 29th day of June, 1995, Eugene D. French and Sharon Lee French, conveyed to Klamath County, Oregon certain property for Public Road purposes, described as follows:

A parcel of land situated in the NW1/4 NE1/4 of Section 34, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, being a portion of Lot 1 and Lot 2, Block 2, "Beverly Heights Addition", more particularly described as follows:

Beginning at a point on the south line of said Lot 1, said point being S.89°39'39"E. 15.00 feet from the southwest corner of Lot 1; thence S.89°39'39"E., along the south line of Lot 1 a distance of 55.00 feet; thence N.06°01'11"W. a distance of 17.16 feet to the beginning of a curve concave to the southwest having a radius of 442.61 feet; thence northwesterly along the arc of said curve a distance of 129.30 feet (the chord of said curve bears N.14°23'19"W., 128.84 feet) to the beginning of a reverse curve concave to the northeast having a radius of 250.00 feet; thence northwesterly along the arc of said curve a distance of 101.10 feet (the chord of said curve bears N.11°10'22"W., 100.41 feet) to a point on a line 15.00 feet east of and parallel with the west line of said Lot 2; thence S.00°24'43"W. along said parallel line, a distance of 240.05 feet to the point of beginning.

The parcel of land to which this description applies contains 0.15 acres more or less. Bearings are based upon record of Survey No. 5647 of Land Partition 48-94 filed in the office of the Klamath County Surveyor.

WHEREAS, the Board of County Commissioners of Klamath County, Oregon sitting in regular session deemed it to be in the best interest of said County to accept the herein described property for Public Road purposes;
