ORDER GRANTING VACATION

ORDER 96-006

Portion of Klamath Street and a portion of 6th Street located in block 7,8,9,12,13 and vacated 6th Street and Emmitt Street, Hessig Addition to Fort Klamath.

KLAMATH COUNTY, OREGON, Situated in SW 1/4 of the NW 1/4 Section 22 T33S R7 1/2 EWM Being more particularly described as follows:

Portion of Klamath Street and a portion of 6th Street located in blocks 7,8,9,12,13 and vacated 6th Street and Emmitt Street, Hessig Addition to Fort Klamath,

Beginning at the southwest corner of Block 7; thence east along the south boundary of lots 5,6,7 & 8 to the southeast corner of Lot 8, Block 7; thence east to the southwest corner of Lot 5, Block 8; thence east along the south boundary of Lots 5,6,7 & 8 to the southeast corner of Lot 8, Block 8; thence south 30.0 feet to the centerline of 6th street; thence east along said centerline 60.0 feet to the northerly projection of the west boundary of Lot 4, Block 12; thence south along said projection of Lot 4 and along said west boundary of Lot 4 to the southwest corner of Lot 4, Block 12; thence west to the southeast corner of Lot 1, Block 13; thence north along the east boundary of Lot 1 to the northeast corner of Lot 1, Block 13; thence west along the north boundary of Lots 1,2 and vacated Lots 3 and 4 to the northwest corner of Lot 4, Block 13; thence west to the northeast corner of vacated Lot 1, Block 14; thence west along the north boundary of vacated Lots 1,2,3 and 4, Block 14 to the northwest corner of Lot 4, Block 14; thence north 60.0 feet to the point of beginning.

This matter coming before the Klamath County Board of Commissioners upon petitioners Richard Graham, Christine Kenneally, Leonore McAuliffe James Bryant; petition files previously herein which said petition requested a vacation of portion of Klamath Street and a portion of 6th Street located in blocks 7,8,9,12,13 and vacated 6th Street and Emmitt Street, Hessig Addition to Fort Klamath, situated in SW 1/4 of the NW 1/4 Section 22 T33S R7 1/2 EWM, Klamath County, Oregon.

It appearing that said petition contains all the information required for ORS 368.341 (3) and that Earl Kessler, Klamath County Engineer, filed herein a written report containing assessment that the requested vacation of the above streets is in the public interest, said report referred to under ORS 368.351 (1) and

It is further ordered that Richard Graham, Christine Kenneally, Leonore McAuliffe, James Bryant, whose acknowledged signatures are found on the petition filed herein, constitute 100% of the property abutting to the streets proposed to be vacated, now therefore,

It is hereby determined that a vacation is hereby granted without hearing as set forth in ORS 368.351 and

It is further ordered that the following-describer real property known as portion of Klamath Street and a portion of 6th Street located in block 7,8,9,12,13 and vacated 6th Street and Emmitt Street, Hessig Addition to Fort Klamath and the same hereby are, vacated, to-wit:

Beginning at the southwest corner of Block 7; thence east along the south boundary of lots 5,6,7 & 8 to the southeast corner of Lot 8, Block 7; thence east to the southwest corner of Lot 5, Block 8; thence east along the south boundary of Lots 5,6,7 & 8 to the southeast corner of Lot 8, Block 8; thence south 30.0 feet to the centerline of 6th street; thence east along said centerline 60.0 feet to the northerly projection of the west boundary of Lot 4, Block 12; thence south along said projection of Lot 4 and along said west boundary of Lot 4 to the southwest corner of Lot 4, Block 12; thence west to the southeast corner of Lot 1, Block 13; thence north along the east boundary of Lot 1 to the northeast corner of Lot 1, Block 13; thence west along the north boundary of Lots 1,2 and vacated Lots 3 and 4 to the northwest corner of Lot 4, Block 13; thence west to the northeast corner of vacated Lot 1, Block 14; thence west along the north boundary of vacated Lots 1,2,3 and 4, Block 14 to the northwest corner of Lot 4, Block 14; thence north 60.0 feet to the point of beginning.
