LOAN MODIFICATION AGREEMENT

This agreement is made this day of June 21, 1995 between Donald A. Gates and Jeanie V. Gates, husband and wife, as tenants in common (individually and collectively, if more than one, "Borrower") and Washington Mutual, a Federal Savings Bank (the "Bank").
