

MEMORANDUM OF LAND SALE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that on July 5, 1995, KLAMATH COUNTY, a Public Corporation of the State of Oregon, as vendor and Carl B. Thornton, as vendee(s) made and entered into a certain Land Sale Agreement wherein said vendor agreed to sell to said vendee(s) and the latter agreed to purchase from said vendor the fee simple title in and to the following described real property in Klamath County, State of Oregon, to-wit:

The E1/2 NW1/4 SW1/4 SE1/4 Section 34, Township 32 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon.

SUBJECT TO covenants, conditions, restrictions, reservations, easements, rights and/or rights of way of record affecting said property.


RESERVING THEREFROM an easement of fifteen feet in width along all exterior boundaries for ingress and egress.

The true and actual consideration of the transfer, set forth in said Land Sale Agreement is \$14,500.00, all deferred payments bear interest at the rate of 9% per annum from the date of said Land Sale Agreement until paid.


