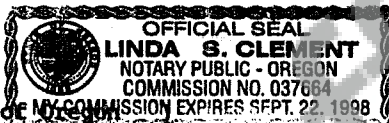
The description is changes from the following described property hereinafter called first description and shown in Exhibit A.

TOGETHER WITH an undivided interest in all those private roads shown on the plat and more particularly described in Declaration recorded in Volume M84, page 4256, Microfilm Records of Klamath County, Oregon.

TOGETHER WITH a parcel of land being a portion of Lot 9 and Lot 10, Block 4, Tract 1257, Resubdivision of a portion of the First Addition to Shield Crest, Klamath County, Oregon, more particularly described as follows:

Beginning at a 5/8" iron rod marking the Northwest corner of Lot 9, Block 4, of said Tract 1257; thence South 46 degrees 34' 59" East a distance of 39.60 feet to a 3/4" brass tag marked LS 993 in the top of a 6x6 wood fence post; thence North 60 degrees 23' 53" East a distance of 88.22 feet to a point on the North line of Lot 9; thence South 81 degrees 10' 56" West, along said North line, a distance of 106.73 feet to the point of beginning.

EXCEPTING THEREFROM a parcel of land being a portion of Lot 8, Block 4, Tract 1257, Resubdivision of a portion of the First Addition to Shield Crest, Klamath County, Oregon, more particularly described as follows:

Beginning at a 5/8" iron rod marking the Southeast corner of Lot 8, Block 4 of said Tract 1257; thence South 81 degrees 10' 56" West along the South line of said Lot 8, a distance of 103.53 feet; thence North 60 degrees 23' 53" East a distance of 97.84 feet to a 5/8" iron rod on the Westerly right of way of Shield Crest Drive; thence Southeasterly along the arc of a 330 foot radius curve, concave to the East (chord = South 27 degrees 58' 12" East, 36.75 feet), a distance of 36.77 feet to the point of beginning.
