Beginning at a point where the South boundary line of the N1/2 of the S1/2 of Section 33, Township 37 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, intersects the Westerly boundary line of Old Fort Road, thence West along the South boundary line of the N1/2 of the S1/2 of Section 33, 2332.77 feet; thence North 662.22 feet; thence East 1836.26 feet to a point on the Westerly boundary line of Old Fort Road; thence following said Westerly boundary line of Old Fort Road in a Southeasterly direction to the point of beginning.
