DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated July 16, 19 70, executed and delivered by EDWARD D. THOMPSON & LOIS L. 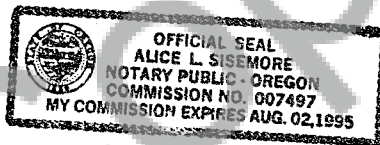
