# BEFORE THE BOARD OF COUNTY COMMISSIONERS KLAMATH COUNTY

# IN THE MATTER OF THE APPEAL OF TUP 1-95, CLAUDE G. REX, JR.

# **1. NATURE OF THE CASE:**

The referenced case, a Temporary Use Permit allowing occupancy of an RV during development of a site, was heard by the Klamath County Hearings Officer on JUNE 2, 1995. An ORDER CONDITIONALLY APPROVING the request on Lot 21, Blk 91 KFFE was entered JUNE 5, 1995. The appellant filed, on June 12, 1995, an appeal of the timeframe for installation of an approved septic system, July 5, 1995. A hearing on this appeal was conducted by the Board of County Commissioners AUGUST 3, 1995.

The appeal was heard pursuant to the procedure set out in Article 33 of the Klamath County Land Development Code.

## 2. THOSE WHO PARTICIPATED:

Claude Rex, Jr. and Mike Wynn argued in behalf of the appeal. Ron Smiley argued against the appeal. The Planning Department was represented by Kim Lundahl, Senior Planner. Karen Burg, Planning Assistant, was the recording secretary. Members of the Board who heard the appeal were: C. H. McMillan, III, Dave Henzel, and F. Jean Elzner.

## 3. CASE DESCRIPTION:

The Hearings Officer APPROVED the Temporary Use Permit subject to installation of an approved septic system by July 5, 1995 on property located on Cardinal Dr., Bly Mtn. T.A. 3711-22A-2600.

The appellant argued the timeframe allowed by the Hearings Officer was to constraining given the financial situation of the appellant and the physical difficulty of the installation.

#### 4. FINDINGS:

The Board finds the appellant has demonstrated progress towards installation of the required septic system and UPHOLDS the appeal conditioned on:

1. The appellant will install the required additional 500 gallon tank and pump by SEPTEMBER 5, 1995 and receive approval for same from the Environmental Health Services Division.

2. The appellant will complete installation and receive approval of the complete system by OCTOBER 30, 1995 or vacate the property. A STIPULATED AGREEMENT confirming the appellants intention to complete or vacate by October 30, 1995 is attached.

# 5. ORDER:

The Board of Commissioners, upon review of the record, testimony and argument presented, UPHOLDS the decision of the Hearings Officer as conditioned above.
