On November 2, 1994, a notice of intent to fine Larry J. Hoff 6 was issued by certified mail by the Real Estate Commissioner to 7 Mr. Hoff's last known address of record with the Real Estate 8 On November 21, 1994, the certified mailing was returned Agency. 9 to the Real Estate Agency with the postal notation "unclaimed" 10 affixed. On November 22, 1994, the notice of intent to fine was 11 mailed to Mr. Hoff at the same address in a handwritten envelope 12 by regular mail, which has not been returned to the Real Estate 13 Agency. Over twenty (20) days have elapsed since the mailing of 14 the notice issued in this matter and no written request for 15 (******• hearing has been received. 16

Copies of the entire investigation file are entered into the record and made a part of this order as is all information in 18 the administrative file relating to the mailing of notices and 19 any responses received. 20

Based on the foregoing and upon a review of the above 21 described investigation reports, documents and files, the Real 22 Estate Commissioner finds that Oregon Administrative Rule 23 863-01-006 states, in part, that a notice of intent is properly 24 served when deposited in the United States mail, registered or 25 1 - ORDER ON DEFAULT Page

certified mail, addressed to the individual at their last known 1 address of record with the Agency; that Mr. Hoff's last known 2 address of record with the Real Estate Agency was 4648 Crosby, 3 Klamath Falls, Oregon 97603; that a certified mailing of the 4 notice of intent was mailed to Mr. Hoff at his last known address 5 of record on November 2, 1994; that a mailing to the same address 6 7 in the handwritten envelope has not been returned to the Real Estate Agency; that, in accordance with ORS 40.135(1)(q), there 8 is a presumption that the mailing properly addressed and placed 9 with the U.S. Postal Service was delivered to Mr. Hoff and that 10 presumption is not overcome by any evidence; that over twenty 11 12 (20) days have elapsed since the mailing of the notice and no written request for a hearing has been received; and the 13 Commissioner further finds that Larry J. Hoff has violated the 14 provisions of ORS 696.020(1) and that he did commit the acts set 15 16 forth in the notice issued herein.

THEREFORE, IT IS HEREBY ORDERED that, pursuant to ORS 696.990(4), and based upon the violations set forth above, Larry J. Hoff pay a fine in the sum of \$15,500, said fine to be paid to the General Fund of the State Treasury by paying the same to the Real Estate Agency
