CORRECTION WELL AGREEMENT

- C. There is a developed well, which is situated on the boundary line that divides the property of Clinton Gardner and Audrey K. Gardner, and A. L. Gardner and Shirley M. Gardner, which well is approximately 125 feet from the Westerly boundary of said property and is approximately 25' x 25'.
- D. The parties hereto desire to reach an agreement for the joint use and maintenance of said well.

NOW, THEREFORE, the parties hereto agree as follows:

- 1. That each party hereto shall have the joint use of said well.
- That each party share one half the expenses for maintenance, upkeep, repair, and cost of operation of said well.
- 3. In the event that either party refuse to pay his share of maintenance, upkeep, repair and cost of operation of said well, then the other party may bring suit for said expenses and receive, in addition to said damages, a reasonable sum as attorney's fees.
- 4. Neither party shall use the well or pump for any use other than domestic use and neither party shall, in any way, damage said well or pump without being liable for the damage, plus reasonable attorney's fees in the event suit is instituted to collect said damages.
