## SUBORDINATION AGREEMENT

THE U.S. SMALL BUSINESS ADMINISTRATION, an Agency of the United States Government, (hereinafter referred to as SBA), hereby represents that it is the owner and holder of a lien on certain real estate of <u>Gary L. Whisler, Jr. and Suzanne B. Whisler, who acquired title as Suzanne Balding Whisler</u> (hereinafter referred to as Borrower).

SAID LIEN was created by Borrower's execution and deliverance of a Deed of Trust recorded December 27, 1993, Instrument No. 73403, Book 93, Page 34697, in the office of the County Recorder, County of Klamath State of Oregon, to secure a Note in the original principal amount of \$25,600.00. Said real estate is fully described and set forth in that Deed of Trust.

BORROWER has requested the SBA to subordinate said Deed of Trust to a Deed of Trust in favor of <u>Beneficial Oregon Inc.</u> securing a Note in a principal sum not to exceed \$38,000.00, and the SBA has agreed to so subordinate.

NOW THEREFORE, the SBA does hereby subordinate its Deed of Trust on said property to a Deed of Trust on the identical property in favor of <u>Beneficial Oregon Inc.</u> securing a Note in a principal sum not to exceed \$38,000.00, and recorded or to be recorded on or about <u>September 5,1995</u> or concurrently herewith in the office of the County Recorder of said County.

SAID SUBORDINATION shall be limited to amounts due to lender for principal and interest payments on said principal sum not to exceed \$38,000.00 and advances to preserve the security thereof including advances for tax payments and insurance.

NO SUBORDINATION is intended or made as to any advances made under a clause to secure future advances, if any, in the Deed of Trust of <u>Beneficial Oregon Inc.</u>.
