RESOLUTION # 96-019

WHEREAS, on the 29nd day of August, 1995 the City of Klamath Falls conveyed to Klamath County, Oregon certain property for Public Road purposes, described as follows:

A parcel of land located in the NW1/4 of the NE1/4 of Section 34, T.38 S., R.9 E., of the Willamette Meridian, Klamath County, Oregon, being a portion of Lot 4, Block 2, Beverly Heights and being more particularly described as follows:

Beginning at the southwest corner of said lot 4; thence following the westerly boundary of said lot 4, 95.55 feet along the arc of a 174.63 foot radius curve to the right, the long chord of which bears N.29° 38' 33" E., 94.36 feet; thence 15.67 feet along the arc of a 333.76 foot radius curve to the left; the long chord of which bears N.43° 58' 19" E., 15.66 feet; thence, leaving said westerly boundary of lot 4, southwesterly 79.00 feet along the arc of a 150.00 foot radius curve to the left, the long chord of which bears S.27° 32' 22" W., 78.09 feet; thence southwesterly 24.81 feet along the arc of a 500.00 foot radius curve to the left, the long chord of which bears S.13° 52' 24" W. 24.81 feet to a point on the southerly boundary of said lot 4; thence N.89° 50' 00" W., 15.49 feet to the point of beginning. Said parcel containing 0.02 acres more or less.
