DEED OF RECONVEYANCE

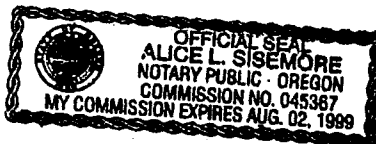
