Said facilities to be placed along and adjacent to an Easterly-Westerly roadway, as it exists, located along and adjacent to the Northerly boundary of said described property.

ALSO, a parcel of land situated in the SW $\frac{1}{4}$ NW $\frac{1}{4}$  Section 22, T.36S., R.12E., W.M., said parcel being more particularly described in that Bargain and Sale Deed recorded December 12, 1994 in Book M94 of Deeds at Page 37594 of Klamath County Records. Said facilities to be placed along and adjacent to an Easterly-Westerly roadway, as it exists, located along and adjacent to the Southerly boundary of said parcel.

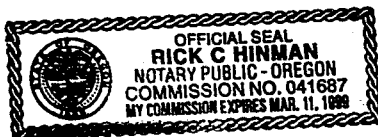
