

## QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That RUDOLPH KUNZ, hereinafter called grantor(s), for the consideration hereinafter stated, does hereby remise, release and quitclaim unto OLGA BRADSHAW, as Trustee(s) for the RUDOLPH KUNZ BUSINESS TRUST, hereinafter called grantee(s), and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

The Southeast quarter of the Southwest quarter (SE1/4SW1/4) of Section Eleven (11) in Township Forty-one (41) South of Range Twelve (12) East of the Willamette Meridian, situated in Malin County, State of Oregon. Klamath P.K.

Reservations as shown in Deed from Lakeside Company, a corporation, to B. T. Hnizda, dated Nov. 15, 1909 and recorded Nov. 21, 1910 in Book 30, page 405 of Deed Records of Klamath County, Oregon, as follows: "Except county roads, telephone, canals and other rights of way heretofore acquired."

Including two wheel lines and mainline and pump which go with the property.

To have and to hold the same unto the grantee and grantee's heirs, successors and assigns forever.

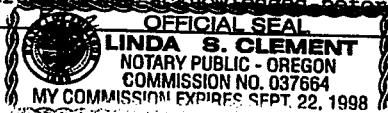
In construing this deed, where the context so requires, the singular includes the plural and all grammatical changes shall be made so that this deed shall apply equally to corporations and to individuals.
