KNOW ALL MEN BY THESE PRESENTS, That RUDOLPH KUNZ, hereinafter called grantor(s), for the consideration hereinafter stated, does hereby remise, release and quitclaim unto OLGA BRADSHAW, as Trustee(s) for the RUDOLPH KUNZ BUSINESS TRUST, hereinafter called grantee(s), and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Northeast quarter of northwest quarter (NE 1/4 NW 1/4) of Section Fifteen (15), Township Forty-One (41) South, Range Twelve (12) East Willamette Meridian, situated in Malin County, Oregon. KLAMATH B.H.

SUBJECT to such rights of way as may be required by Malin Irrigation District for canals and ditches and for such roads as are necessary to serve other lands sold in the vicinity of those hereinabove described and also subject to county road, telephone, canal and other rights of way acquired, reserved, or granted thereon, and existing contracts, agreements, waivers, trust deeds and other obligations to the United States and Klamath Water Users Association heretofore executed by the grantor or its predecessors in interest.

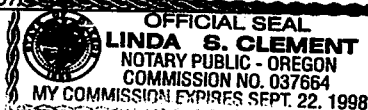
In construing this deed, where the context so requires, the singular includes the plural and all grammatical changes shall be made so that this deed shall apply equally to corporations and to individuals.
