INDENTURE OF ACCESS

WHEREAS, State by deed recorded April 28, 1994, in Volume M94, Page 13469, Klamath County Deed Records, acquired from Hanson Natural Resources Company, a Delaware partnership consisting of Cavenham Forest Industries, Inc., a Delaware corporation; Gold Fields Mining Corporation, a Delaware corporation; and Cavenham Energy Resources, Inc., a Delaware corporation, certain property situated in Sections 1, 11, 12, 13, 14, 23, 24, 25, 26, 35, and 36, Townships 30, 31, 32, and 33 South, Range 7 East, W.M., Klamath County, Oregon, which deed, in part, reserved access rights, for the service of said grantor's remaining property, to and from the West side of the relocated The Dalles-California Highway, opposite Engineer's Station 2482+50; and

WHEREAS, Owner has requested that its access rights opposite said Station 2482+50 be moved, and that access rights be substituted, therefor to and from the West side of said highway opposite Engineer's Station 2551+00; and

WHEREAS, State is agreeable to the granting of Owner's request.

NOW THEREFORE, THIS INDENTURE WITNESSETH, that for and in consideration of the grant hereinafter made by State, OWNER does transfer and relinquish unto State, its successors and assigns, Owner's access rights to and from the West side of the relocated The Dalles-California Highway opposite said Station 2482+50, reserved in said deed recorded April 28, 1994. Owner represents and warrants that no one, other than Owner, is using or entitled to

STATE, in consideration of the relinquishment and warranties herein made, does grant access rights unto Owner, its successors and assigns, to and from the West side of said highway, opposite said Station 2551+00, in a width of 35 feet, and unrestricted as to use.

The access rights reserved herein are subject to the statutes and regulations controlling access to the highway system. A standard Approach Road Permit must be applied for and obtained from the Oregon Department of Transportation's District Maintenance Office before construction is begun. When the State constructs the approach road, Grantee will be required to sign a standard Approach Road Permit to assure proper operation and maintenance of the approach road.
