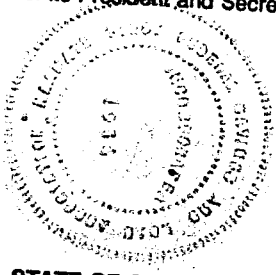


SATISFACTION OF MORTGAGE

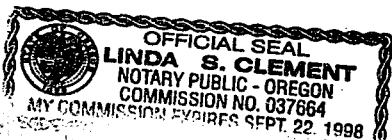
