AMENDMENT

WHEREAS, Maria Egbert, a widow, hereinafter called first party, and PACIFIC GAS TRANSMISSION COMPANY, a California corporation, hereinafter called second party, entered into that certain Right of Way Agreement dated August 11, 1994 and recorded in Volume M94 at Page 26695 of Official Records of Klamath, County, Oregon; and

WHEREAS, second party proposes to change the location of the right of way strip described in the above referenced Right of Way Agreement;

NOW THEREFORE, in consideration of value paid by second party, the adequacy and receipt of which are hereby acknowledged, it is agreed between the parties that the description of the right of way strip be amended as follows:

1) The Right of Way strip (35' wide) is relocated as described on Exhibit "B1" attached hereto and made a part hereof.

2) The right to use a strip of land thirty feet (30') in width is now located contiguous to the north boundary of the Right of Way strip.

All other terms and conditions of the above referenced Right of Way Agreement shall remain the same. The provisions herein granted shall inure to the benefit of and bind the heirs, successors, and assigns of the respective parties hereto, and all covenants shall apply to and run with the land.

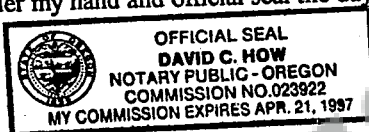

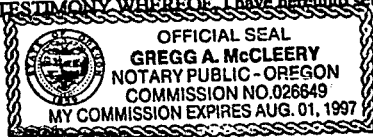

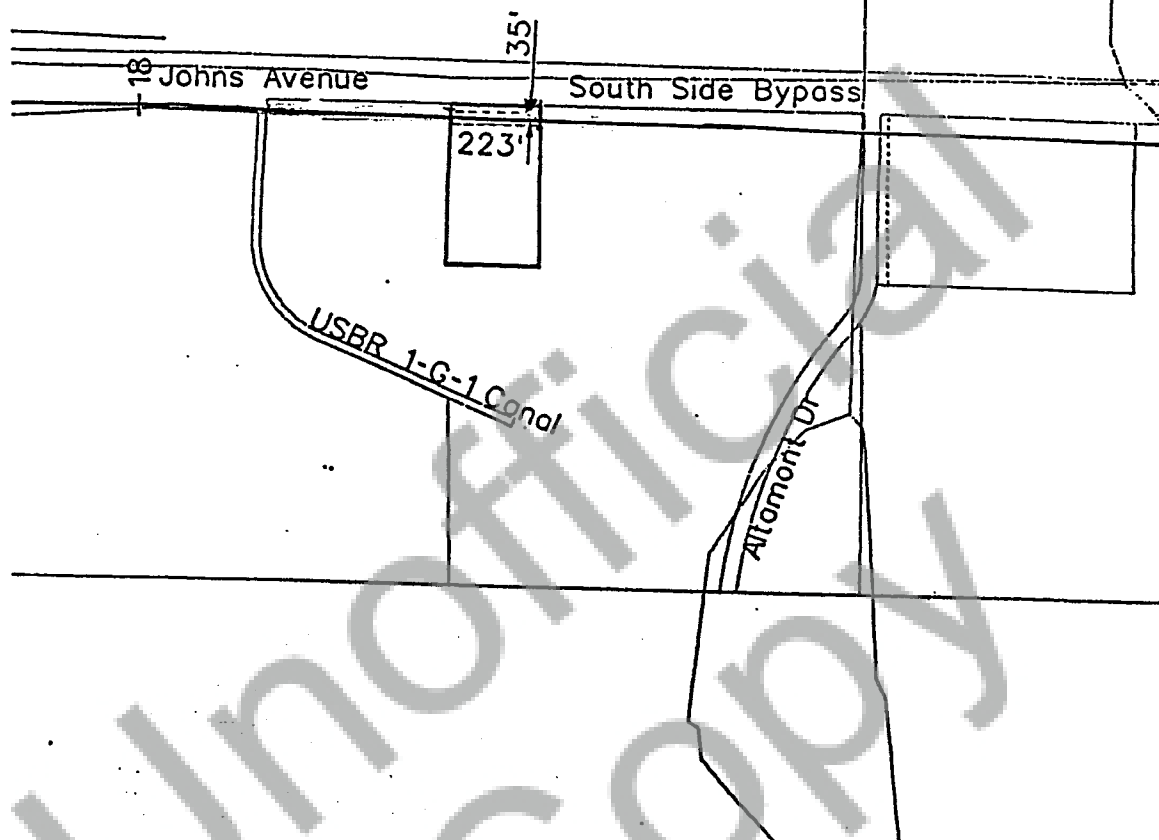
