NOW KNOW YE, That the **UNITED STATES OF AMERICA**, in consideration of the premises, and in conformity with the several Acts of Congress in such behalf passed, and provided, **HAS GIVEN AND GRANTED**, and by these presents **DOES GIVE AND GRANT**, unto the said **JOHN W. HARRIS**, his heirs and assigns forever, the right and privilege, unto the said **HARRIS**, his heirs and assigns forever, **TO HAVE AND TO HOLD** the same, together with all the rights, privileges, immunities, and appurtenances, of whatsoever nature, thereunto belonging, unto the said claimant and to the heirs and assigns of the said claimant forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the local customs, laws, and decisions of courts; and there is reserved from the lands hereby granted, a right of way thereon for ditches or canals constructed by the authority of the United States.
