2. We are now living on the particular land located in the Ninth Judicial District, Klamath County, Klamath Falls, Oregon, described as:



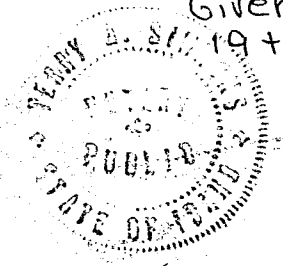
3. No former Declaration Of Homestead has been made by me except as has been abandoned; and,
