TRACT 42 OF HOMEDALE, ACCORDING TO THE OFFICIAL PLAT THEREOF ON FILE IN THE OFFICE OF THE COUNTY CLERK OF KLAMATH COUNTY, OREGON, SAVING AND EXCEPTING THE SOUTH EASTERLY 65 FEET OF TRACT 42 OF HOMEDALE, OUT OF BY A LINE 65 FEET NORTH WESTERLY OF AND PARALLEL WITH THE SOUTH EASTERLY LINE OF SAID TRACT 42.

To Have and to Hold the same unto the grantee and grantee's heirs, successors and assigns forever.

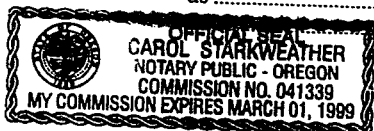
