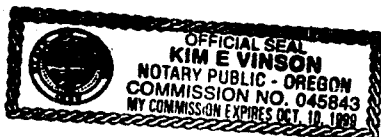
This guardianship shall begin on October 24, 1995, and shall remain effective through July 1, 1996.
