LOG TRAILER LOADER - Constructed with 18" H-boom, 25 HP gear reducer, cable drum hoist with brake.

VENEER TRUCK SCALE - Electric ramp scale made for dual axle weighing.

LOG TRUCK SCALE - HOWE balance beam platform scale.

BOILER - The boiler house is an all steel building with a 40 unit fuel house adjacent to it. The boiler is a wood fired 500 HP KEELER, with water purification system, 12 starter control circuits, turbine fed water pump, I.D. fan, and particulate detector system.

STEAM VATS - Six 12' x 18' x 110' concrete tunnels with cantilever doors and hydraulic controls. The heat system has 3 HARRIS heat exchangers, three 30 HP 1500 gal. sump pumps and condensate return.
