KNOW ALL MEN BY THESE PRESENTS, That ROBERT FRANKLIN PARKER, SR., TRUSTEE OF THE PARKER TRUST

, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto ROBERT F. PARKER, JR.

hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A piece or parcel of land situated in the N $\frac{1}{2}$ SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 11, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more fully described as follows:

Beginning at a point in the centerline of a 60 foot roadway, from which the section corner common to Sections 2, 3, 10 & 11, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, and as marked on the ground by an iron pin driven therein, bears South 89°44 $\frac{1}{2}$ ' West along the said roadway centerline 1485.2 feet, to a point in the West boundary of the said Section 11, and North 0°13 $\frac{1}{2}$ ' West, 1662.5 feet to said section corner and running thence South 0°01' East 331.4 feet to a point in the Southerly boundary of the said N $\frac{1}{2}$ SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 11; thence North 89°42' East along said boundary line 65.7 feet; thence North 0°01' West 331.35 feet, more or less, to an intersection with the center line of the above mentioned roadway; thence South 89°44 $\frac{1}{2}$ ' West along said roadway center line 65.7 feet, more or less, to the said point of beginning.

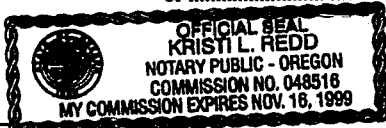
