MODIFICATION OF MORTGAGE

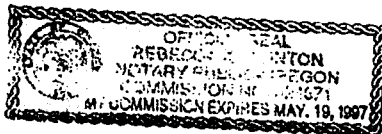

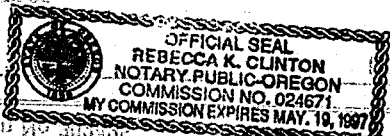
