

MEMORANDUM OF LAND SALE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that on November 1, 1995, **KLAMATH COUNTY**, A Public Corporation of the State of Oregon, as vendor and Lanny H. Wollaston & Roberta Wollaston, as Tenants by the Entirety, as vendee(s) made and entered into a certain Land Sale Agreement wherein said vendor agreed to sell to said vendee(s) and the latter agreed to purchase from said vendor the fee simple title in and to the following described real property in Klamath County, State of Oregon, to-wit:

The true and actual consideration of the transfer, set forth in said Land Sale Agreement is \$5,050.00, all deferred payments bear interest at the rate of 9% per annum from the date of said Land Sale Agreement until paid.

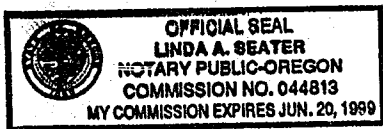
