KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated June 26th, 1973, executed and delivered by DEE C. VALENTINE and META P. 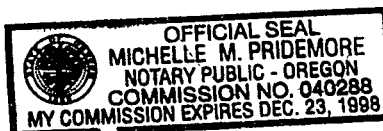
