  - 1.4. There exists an easement across the property owned by Wilcynski described as:

A 60 foot easement on on the easterly portion of said property, a 30 foot easement on the Westerly portion of said property, a 30 foot easement on the Northerly portion of said property, and a 30 foot easement on the southerly portion of said property, all for roadway purposes.
