# WARNING TO PERSON EXECUTING THIS DOCUMENT

THIS IS AN IMPORTANT LEGAL DOCUMENT. IT CREATES A DURABLE POWER OF ATTORNEY. BEFORE EXECUTING THIS DOCUMENT, YOU SHOULD KNOW THESE IMPORTANT FACTS:

THE POWERS GRANTED BY THIS DOCUMENT ARE BROAD AND SWEEPING.

THIS DOCUMENT MAY PROVIDE THE PERSON YOU DESIGNATE AS YOUR ATTORNEY IN FACT WITH BROAD POWERS TO MANAGE, DISPOSE, SELL AND CONVEY YOUR REAL AND PERSONAL PROPERTY AND TO BORROW MONEY USING YOUR PROPERTY AS SECURITY FOR THE LOAN.

THESE POWERS WILL EXIST FOR AN INDEFINITE PERIOD OF TIME UNLESS YOU LIMIT THEIR DURATION IN THIS DOCUMENT. THESE POWERS WILL CONTINUE TO EXIST NOTWITHSTANDING YOUR SUBSEQUENT DISABILITY OR INCAPACITY.

YOU HAVE THE RIGHT TO REVOKE OR TERMINATE THIS POWER OF ATTORNEY.

IF YOU HAVE ANY QUESTIONS ABOUT THESE POWERS, OBTAIN COMPETENT LEGAL ADVICE.

1. DESIGNATION OF AGENT. I, AIMEE G. PARK, of LOS ANGELES County, CALIFORNIA, do hereby appoint EUGENE W. PARK as my attorney in fact (agent), to act for me in any lawful way with respect to the below initialed subjects. If EUGENE W. PARK is unable or unwilling for any reason to act, then I appoint JENNIFER D. BRAGG as my attorney in fact (agent).

2. STATEMENT OF AUTHORITY GRANTED.

6. NOMINATION OF CONSERVATOR OF THE ESTATE. If a conservator of the estate is to be appointed for me, I nominate the following person to serve as conservator of the estate: EUGENE W. PARK. If EUGENE W. PARK is unable or unwilling for any reason to act, I nominate JENNIFER D. BRAGG.
