THE KLAMATH TRIBES

This matter came before Michael L. Brant, Hearings Officer for Klamath County, Oregon, on December 1, 1995, in the Klamath County Museum Meeting Room in Klamath Fal's, Oregon. The hearing was held pursuant to notice given in conformity with the Klamath County Land Development Code and related statutes and ordinances. The Klamath County Planning Department was represented by Mr. Kim Lundahl and the recording secretary was Ms. Karen Burg. The Klamath County Planning Department file and all the exhibits and other contents therein is incorporated by this reference into this matter. The Klamath County Planning Department staff report was received. Based upon the evaluation of the staff report and consideration of the evidence received, the hearings officer makes the following findings of fact and conclusions and makes the following decision.

## FINDINGS OF FACT

The applicant requests a conditional use permit to establish The Klamath Tribes Beatty Community Center on a five (5) acre parcel of property zoned R-5 located on the northwest corner of Godowa Springs Road and Highway 140E, Beatty, Oregon, T.A. 3612-15D-301. The Applicant proposes to construct a 2900 square foot community center on the property occupied by the condemned Beatty Methodist Church building which was heavily damaged by the 1993 earthquakes. The church building is to remain and the community center facility will be nearby.

## CONCLUSION

There is no reasonable basis upon which to deny the requested conditional use permit. The proposed use is in compliance with the requirements of the KCLDC Article 44, Section 44.030 A, B, and C.

## ORDER

It is hereby ordered that the requested conditional use permit 84-95 is granted. A Site Plan Review as required by Article 41 is required prior to final Planning Department approval. DATED THIS 1st day of December, 1995.
