TERMINATION OF EASEMENT

THIS TERMINATION OF AN EASEMENT is made this 2/2 day of <u>November</u>, 1995, by the United States of America, by and through the Forest Service, Department of Agriculture, hereinafter referred to as "Government," to Weyerhaeuser Company, successor in interest to Crown Zellerbach Corporation, hereinafter referred to as "Cooperator."

WHEREAS, both the Government and the Cooperator do intend and agree that the Subsequent Easement shall supersede the Initial Easement, and shall govern the rights of the Government and the Cooperator for use of the land and the road thereon subject to such Subsequent Easement,

NOW THEREFORE, in consideration of the grant by the Cooperator of said Subsequent Easement, the Government hereby releases, relinquishes, and discharges to the Cooperator all rights created by and arising from or out of the aforesaid Initial Easement except for such rights also granted and continued in the Subsequent Easement. Said Subsequent Easement is in no way affected by this termination and shall remain in full force.

IN WITNESS WHEREOF, the United States of America, by the <u>Activ</u> Director of Recreation, Lands, and Mineral Resources, Pacific Northwest Region, Forest Service, pursuant to the delegation of authority published August 28, 1984 (49 FR 34283), has executed this Termination of Easement on the day and year first above written.
