WHEREAS, Favel-Utley Realty Company granted to the United States of America an easement for a telephone line dated October 1, 1932, and recorded December 17, 1932, in Book 99, page 288, County of Klamath, State of Oregon, over and across the following described premises:

"This grant shall be effective so long as said easement shall be actually used for the purposes above specified but all rights hereunder shall revert to the owner of the land as soon as the said use thereof shall be abandoned and discontinued,"

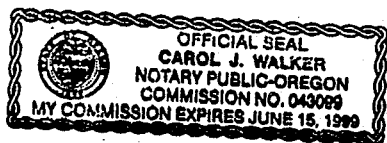
