

MEMORANDUM OF LAND SALE AGREEMENT

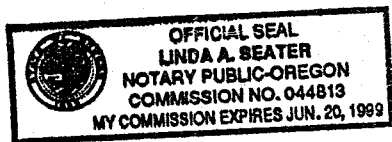
