A one third of an undivided one fourth interest in a recreational residence and adjacent sleeping cabin with furnishings and equipment, a floating dock and a nineteen foot fiberglass boat with trailer, located on Block C, Lot 9, Lake of the Woods homesites.

TO HAVE AND TO HOLD the same unto the buyer and buyer's heirs, executors, administrators, successors and assigns forever.

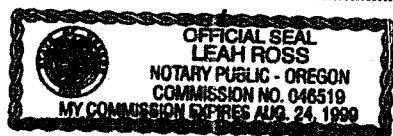
