NOW THEREFORE, in view of the premises, the undersigned hereby appoints ANDREW BRANDSNESS

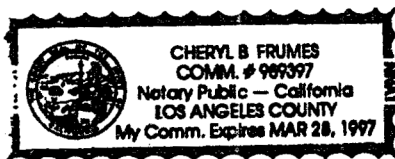
