KNOW ALL MEN BY THESE PRESENTS, That Chester L. Swearingen and Henrietta D. Swearingen, husband and wife, hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and quitclaim unto Susan Alexander (Suz), hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

The Sacle 70 feet of lots 45, 46, 47 and 48 in block 8, St Francis Park, according to the official plat thereof on file in the office of the County clerk of Klamath County, Oregon.
