## MEMORANDUM OF CONTRACT OF SALE

"Subject to the following restrictions: (1) a 20 foot building setback line along the front of all lots and all lots abutting on State Highway 58; (2) No access from highway other than the streets as shown on the annexed plat; (3) A 16 foot public utilities easement along all back and side lot lines except where the lines are common to two lots, an eight foot easement is dedicated on each lot; (4) A 10 foot pedestrian easement along the Easterly bank of Crescent Creek, along the line between Lots 2 and 3, Block 3 and along the portion of the subdivision boundary abutting the parcel of land shown and identified as "not a part of this subdivision" on the annexed plat, for the use of the owners of the lots in BREWERS RANCHOS, their guests and tenants; and any additional restrictions as provided in recorded protective covenants and restrictions of record."
