The purpose of this agreement is to provide security for Lender and County for loans furnished Borrower by Lender and County and to provide security to ensure that County is in compliance with Article 11 Section 9 of the Oregon Constitution (Lending of Credit) and Article 11 of Section 10 of the Oregon Constitution (Debt Limit) by a shared assignment of lease rents from that property commonly known as the Frank N. Ganong Building (see attached legal description), leased by Borrower to International Paper Company. The monthly stream of lease rents will be shared in the ratio of 49% to Lender, and 51% to County. It is hereby acknowledged that for purposes other than sharing of the lease rent proceeds, such as default, that the Lender is in first position on the assignment of lease rents and County is in second position.
