  - (a) All or part of the property is sold or otherwise transferred (other than by devise, descent or operation of law) by Borrower to a purchaser or other transferee, or
  - (b) Borrower rents, leases, or within 60 days after the loan is closed, fails to occupy as the borrower's principal residence the property described in the Deed of Trust, or
  - (c) Borrower omits or misrepresents a fact that is material with respect to the provisions of Section 143 of the Internal Revenue Code in an application for this loan.
- (3) Environmental Evaluation. In the event that foreclosure of the Deed of Trust and Note is imminent, an environmental evaluation may be required. The borrower will pay the cost of such environmental evaluation.
- (4) Flood Insurance.
