NORTHWEST TRAILER SALES will not open a repair center for at least 30 days from the date of this agreement.

SWAYTAMER will receive a 10% ^{the net profit of} commission on any unit sold from SWAYTAMER lot or NORTHWEST TRAILER SALES that was referred by SWAYTAMER in either personal contact or phone information given by SWAYTAMER as long as the purchaser verifies original contact as SWAYTAMER in either a personal contact or phone information. *K.B. CJE*

NORTHWEST TRAILER SALES WILL CONDUCT ALL THOROUGH TRAILER DISPLAY AND CLOSE ALL DEALS BY WAY OF FINAL PRICE, TRADE OR CONSIGNMENTS AND WILL WORK ALL PAPERWORK INVOLVED WITH SALE. SWAYTAMER NEED ONLY REFER A CONTACT CUSTOMER FROM EITHER PERSONAL OR PHONE CONTACT TO RECEIVE COMMISSION AS MENTIONED ABOVE UPON CLOSURE OF SALE.

THIS AGREEMENT MAY BE REVOKED UPON 24 HOUR NOTICE FROM EITHER PARTY AND BOTH PARTIES AGREE TO ACCESS OF SWAYTAMER LOT FOR TRAILER REMOVAL.




