96 FEB 23 TERMINATION OF A SEGMENT OF AN EASEMENT

THIS TERMINATION OF A SEGMENT OF AN EASEMENT dated this 30 day of November, 1995, by the United States of America, acting by and through the Forest Service, Department of Agriculture.

WHEREAS, The United States of America granted to Weyerhaeuser Company an easement for roads dated, January 6, 1982, and recorded January 25, 1982, in Book M 82, at page 991, Records of Klamath County, State of Oregon, which easement contained the following provisions:

"The Chief, Forest Service may terminate this easement, or any segment thereof, (1) by consent of the Grantee, (2) by condemnation, or (3) after a five (5) year period of nonuse, by a determination to cancel after notification and opportunity for hearing as prescribed by law; provided the easement, or segment thereof, shall not be terminated for nonuse so long as the road, or segment thereof, is being preserved for prospective future use."

WHEREAS, for good and valuable consideration, Weyerhaeuser Company, grantee, by joining in the execution of this document, consents to the termination of a portion of said easement over and across the following described lands as shown on Exhibit A attached hereto; and

WHEREAS, said easement provided that the Chief, Forest Service, may terminate the easement or any segment thereof by consent of the Grantee;

NOW THEREFORE, the United States of America, by the Forest Supervisor, Fremont National Forest, pursuant to the delegation of authority by the Regional Forester, Pacific Northwest Region, Forest Service, 58 F.R. 30766, published May 27, 1993, does hereby terminate the said easement.


